525.1	<b>Burial Space</b> - Mrs Potts (Chairman, Malling Society) explained that burial space was needed at Kings Hill.			

525.2	<b>Streetlight, Swan Street</b> – Mrs Javens commented that she felt that the lack of a KCC light in Swan Street constituted a potential trip hazard; this had been reported to KCC several times but Mrs Javens would do so again on 03000 418181.	LJ		
15/	<b><u>POLICING MATTERS</u></b>			
526.1	<b>Policing Report</b> – although not able to attend in person, PCSO Harrison had submitted his report which the Clerk had circulated to members. (see Appendix 1)			
526.2	<p><b>Other Policing Matters</b> – Mrs Dean welcomed Sgt Boxall to the meeting. Sgt Boxall asked to be provided with a copy of the e-mail from Sgt Mott about the provision of CCTV in Police Station Road, viz:</p> <p>“.....As you are aware, neither Kent Police or TMBC are able to put up an overt camera at the location [Police Station Road] due to lighting and the positioning of suitable lamp posts for power supply. I recall that the only one that Andrew Young from TMBC thought was a possibility was the one opposite the junction on Swan Street but this does not show the location where the cars are being damaged due to a small curve in the road.</p> <p>The only other option for technical support was a covert camera. This was considered but due to the time space between reported incidents, was not possible as they can only remain for a very limited period under legislation.</p> <p>I saw that there was a further reported incident last week but this was the first since June. There have been five incidents this year – February, March, April, June and October – all of scratches to vehicles. I agree that this is excessive damage and indicates still that the offender is local and shrewd enough to space out his offending to make it very difficult to detect. “</p> <p>Members were pleased that the incidence of anti-social behaviour had decreased.</p> <p>Mrs Dean referred to The Lobster Pot: problems had been reported to T&amp;MBC.</p>	Clerk	✓

WMPC's rent was a peppercorn rent.</p>

## APPENDIX 2

### REPORT FROM CNTY CLLR MRS DEAN

County Councillors Report for

November 2015 Parish Council meeting.

1. This year's Dragon's Den event will take place on November 21st at 12 noon beginning with lunch. Application forms must be obtained from Anne.charman@kent.gov.uk in advance.
2. The SoS for Education has approved the opening of a Girls Grammar School provision as an annexe to Weald of Kent Girls Grammar School on the previous Wildernesse School site in Sevenoaks. It is possible, though unlikely that pupils from this area may gain access to it, but transport costs would have to be borne by parents.

East Malling and Larkfield

2. KCC Property Department has accepted there is a gap in their procedure of reporting KCC land for entry on the Call for Sites Map without reference to Council Members, and say they will address this in future. I understand they have placed any KCC land or property which they believe KCC might wish to develop by 2031 on the map. I have asked why the Martin Square Family Centre was not included. I am advised they did not encourage EMRS to place their site on the map.
3. Street Lighting Consultation documents. I have a stock of the full response from which the Parish Council is welcome to have. My application for returning to lighting the Redwing Close and alleyway between Kingfisher and Heron Road have both been refused.
4. The park run at Leybourne Lakes continues to attract over 300 runners, and the Junior run at Manor Park is now in its second month and is attracting over 100 runners each Saturday.
5. The northern end of New Hythe at the Papyrus Way junction has received some tree and shrub thinning to reduce the dark tunnel which was deterring pedestrians from using the path by the park. An assessment of the need for further maintenance will be carried out soon.
6. Grass on Chaucer Way south of Marlowe Road gardens has been reported for maintenance.
7. The footway to the south of Huntleys Cottage on Wateringbury Road has now been cleared. I have received a refund of £700 in respect of the street light at the speed ramp which proved not necessary and I will put this towards the cost of relocating the 30mph limit to the junction of The Heath and Wateringbury Road. However the cost of the traffic regulation order consultation and signage will be ..... and i would like the Parish Council to contribute towards that cost.
8. A meeting with the Trustees of the St James Centre and KCC Property Department revealed concerns about the water supply and asbestos in the boiler room, both of which are being checked this week prior to the boiler replacement, to which KCC is now committed.
9. I have a site meeting tomorrow to discuss the fate of the magnolia in Busbridge Close. It is reported that many vehicles enter the close believing it to be Stickens Lane because of the misleading nature of the signage and the change of name part way along the cul de sac. . I intend to

consult residents on a proposal to redraw the white lines so that they lead traffic onto Stickens Lane to the right and will report back to the Parish Council.

#### West Malling

10. The Blue Plaque Scheme will be launched on Thursday November 12th at 3pm at 104, High Street.

11. TMBC are offering retail Healthchecks to shops in West Malling free of charge.

12. The Green Cafe in the Country Park is now open again on Friday Saturday and Sunday.

13. TMBC are reluctant to extend residents parking to the houses on London Road opposite the Wheatsheaf as they say this may expose them to liability for the underground utilities, power and fibre optics beneath the paved surface. I have pointed out this situation has existed for over 30 years and I have a site meeting there tomorrow morning.

14. The Remembrance Service will take place on Sunday 8th November starting with the High Street parade at 2pm. I shall try to find a place to display the planning proposals for the Church Centre and display the poster for the PARISH Council Planning Meeting on December 1st.
