	Discussion took place regarding the replacement fencing along the boundary of the children's play area and Woodland Close. The Clerk and Assistant Clerk met with a resident, whose property is on the boundary of the play area, and he expressed his concerns with the work that had been carried out. He feels that the fencing is unsuitable and the removal of the hedge has affected his privacy. The resident has been asked to put the concerns in writing.			
	Mr Stevens said he had also spoken with the resident and suggested that 6ft reed screening, secured to the Parish Council side of the fencing, and the planting of a new hedge will help protect their privacy.			
	Mrs Javens commented on the difference in height at various points. This is due to the ground being uneven. There is a tree stump, remaining, by her fencing. Four Seasons to be asked to look at this.
